Accommodation Dates: Saturday 1 Jul 2018 – Thursday 20 Dec 2018

Guest Rooms: This Agreement applies to the following block of guest rooms (the "Room Block"):

01 – 30 November 2018: 240 room nights

01 – 20 December 2018: 160 room nights

Cut-off Date: The "cut-off date" for reserving rooms in the Room Block is 14:00 p.m. local time at Hotel on 16 May 2017. After the cut-off date, it is at Hotel's discretion whether to accept additional reservations, which will be subject to prevailing rates and availability. Failure to reserve rooms in the Room Block prior to the cut-off date does not reduce Group's total guest room night commitment and does not impact the "Attrition" or "Cancellation" provisions below.

Room rates are nett rates, per room per night, inclusive of tax and service charge and non-commissionable, inclusive of daily breakfast for 02 persons, using gym, pool, sauna, steam bath and Jacuzzi and basic Internet in-room.

During high season (1 July – 3 Sep and 1 – 7 Oct 2018), room rates are inclusive 01 time buffet dinner (Food only) at Feast Restaurant for maximum 02 guests per room per stay of minimum 3 nights.

Minimum stay:

High season: Minimum stay 3 nights and maximum 20% (48 room nights) bookings of 2 nights.

Low season: Minimum stay 2 nights and maximum 10% (24 room nights) bookings of 1 night.

Room rates are applied for Hard Block with minimum 08 Deluxe Ocean View rooms per night from 01 Jul – 20 Dec 2018, inclusive, any room over the Room Block, subject to availability of guest rooms at the time of reservation.

Extra bed is at USD45nett/extra bed/night for extra bed in Deluxe Ocean View room.

Rooms with King size bed – Maximum room occupancy is 02 adults & 01 child aged below 12 years old. Only one extra bed is allowed per King Room.

Twin rooms – Not possible to put extra bed

Additional charge for Breakfast for additional person

- Adult: USD22nett/person
- Children from 03 – under 12 years old: USD11nett/person
- Children under 03 year old: Free of charge

Additional charge for Dinner for additional person (Food only)

- Adult: USD34nett/person
- Children from 03 – under 12 year old: USD17nett/person
- Children under 03 year old: Free of charge

Early Departure Fee: An early departure fee of full charge for the shorten nights will apply if a Group attendee checks out prior to the confirmed checkout date.

Check-in and Check-out Time: Check-in time is **15:00 hours** check-out time is **12:00 hours**. All guests arriving before 15:00 hours will be accommodated as rooms become available. Baggage may be checked-in for those arriving early if rooms are unavailable.

Smoking policy: Smoking is not permitted in non-smoking room, any guest who smokes will be required to pay a fee of USD200nett for cleaning.

All our meeting rooms are non-smoking rooms and smoking is not permitted in non-smoking room, any guest who smokes will be required to pay a fee of **USD2,500nett**.

Minimum Revenue: This Agreement will generate revenue for Hotel from a variety of sources, including guest rooms, and charges for ancillary services. The minimum revenue anticipated by Hotel under this Agreement (including taxes and other charges) is:

808 Deluxe Ocean View Room nights x USD120nett = USD96,960nett

576 Deluxe Ocean View Room nights x USD165nett = USD95,040nett

Total Minimum Revenue: USD192,000nett

During high season (1 July – 3 Sep and 1 – 7 Oct 2018), room rates are inclusive 01 time buffet dinner (Food only) at Feast Restaurant for maximum 02 guests per room per stay of minimum 3 nights.

Each arrival will only have one time buffet dinner.

Hotel will issue vouchers for dinner. 100% of vouchers will be used by in house guests. When Hotel receives rooming list for each arrival hotel will check and reconfirm total number of vouchers if there are any extra third person or extra children in rooms.

Vouchers will be delivered to guest upon group check in

If Group does not fulfill all of its commitments or cancels this Agreement, Group agrees that Hotel will suffer damages that will be difficult to determine. The "Attrition" and "Cancellation" provisions below provide for liquidated damages agreed upon by the parties as a reasonable estimate of Hotel's losses and do not constitute a penalty of any kind.

Attrition: Applied for Low Season 4 Sep – 30 Sep 2018 and 8 Oct – 20 Dec 2018, inclusive

Hotel accept the minimum 6 rooms and maximum 10 rooms materialized per day. Only 2 rooms in total 08 allotment rooms per day can be cancelled before 7 days without charge to move to other days.

Any room nights cancelled on total commitment room nights per month as below will be applied full charge.

01 – 31 July 2018: 248 room nights

01 – 31 August 2018: 248 room nights

01 – 30 September 2018: 240 room nights

01 – 31 October 2018: 248 room nights

01 – 30 November 2018: 240 room nights

01 – 20 December 2018: 160 room nights

Cancellation: If Group cancels this Agreement, Group will provide written notice to Hotel, accompanied (except in the case of a Force Majeure) by payment of the amounts indicated below:

The parties agree that the amounts included in this Cancellation clause are reasonable estimates of the losses that would be incurred by Hotel and factor in Hotel's ability to mitigate its losses through resale.

Guest will pay for individual incidental charges of their stay.

Payment: Unless direct billing has been established, Group will pay the estimated amount of the Master Account as shown on the deposit schedule. Group will advise Hotel of its expected method of payment of the Master Account at least 60 days in advance of **Saturday 1 July 2018**.

Security: Hotel does not provide security in the event and function space and all personal property left in the event or function space is at the sole risk of the owner. Group will advise its attendees that they are responsible for safekeeping of their personal property. Hotel may reasonably require Group to retain security personnel in order to safeguard guests or property in Hotel. Security personnel are not authorized to carry firearms without advance Hotel approval.

Ancillary Services: Hotel may provide, or contract with third parties to provide, ancillary services (e.g., A/V, drayage, florists, exhibitors) to Group for additional charges. Group may use its own vendors for such services provided that Group's proposed vendors meet minimum standards established by Hotel, including insurance and indemnification requirements. With respect to audiovisual services, Group will inform Hotel of its decision to bring its own vendor at least 60 days prior to **Saturday 1 July 2018**, and will sign, and have its audiovisual vendor sign, an acknowledgement of Hotel's Audiovisual Service Standards at least 45 days prior to **Saturday 1 July 2018**.

Relocation: If any guest room reservation cannot be accommodated by Hotel, Hotel will provide: (1) accommodations at a comparable Hotel reasonably nearby at no charge for the first night; (2) one complimentary round trip ground transportation between Hotel and the alternate hotel for each day the guest is displaced; (3) one 5 minute phone call and necessary arrangements for forwarding of the displaced guest's telephone messages and mail; (4) an offer to relocate the displaced guest back to the first available guest room; (5) upgraded accommodations at Hotel upon return (if available) and a welcome expression from the General Manager; and (6) credit to Room Block for any nights that guests are displaced.

Disclosure: Group will be responsible for determining to whom it needs to disclose any terms of this Agreement, including any commission or rebate that it may receive. Group will disclose to all Group attendees the type and amount of all automatic and mandatory charges that will be charged to them by Hotel.

Laws and Policies: Each party will comply with all applicable federal, state and local laws (including the local equivalent of the Americans with Disabilities Act, if any) and Hotel rules and policies. Group will be responsible for providing its disabled members with auxiliary aids in connection with any Group events or activities. Upon Group's reasonable request, Hotel will use reasonable endeavors to cooperate with Group to provide services on behalf of Group's disabled attendees.

Privacy: Group will obtain all necessary rights and permissions prior to providing any personally identifiable information ("PII") to Hotel, including all rights and permissions required for Hotel, Starwood Hotels & Resorts Worldwide, Inc. ("Starwood"), Starwood affiliates, and service providers to use and transfer the PII to locations both within and outside the point of collection (including but not limited to the United States) in accordance with Starwood's privacy statement () and applicable law.

Confidential Information: Group and Hotel will each take reasonable steps to keep all confidential information provided by the other party confidential and to identify information as confidential when shared. Confidential information will not include: (1) information that is publicly available; (2) PII, which will be handled by the parties in accordance with the "Privacy" provision above; or (3) information that is left or discarded in event rooms, public space or guest rooms.

Insurance: Each party will maintain insurance sufficient to cover any claims or liabilities which may reasonably arise out of or relate to its obligations under this Agreement and will provide evidence of such insurance to the other party upon request.

Indemnification: Each party will indemnify, defend and hold the other harmless from any loss, liability, costs or damages arising from actual or threatened claims resulting from its breach of this Agreement or the negligence, gross negligence or intentional misconduct of such party or its officers, directors, employees, agents, contractors, members, or participants. Neither party will be liable for punitive damages.

Dispute Resolution: The parties will resolve any claim or dispute arising out of or relating to this Agreement through binding arbitration before one arbitrator. The arbitration will be conducted in accordance with the rules of the Vietnam International Arbitration Centre in Vietnam, with all proceedings conducted in English or Vietnamese, and the law of Vietnam, will be the governing law. In any arbitration or litigation arising out of or relating to this Agreement or the enforcement of any arbitration award, the prevailing party will recover attorneys' fees and costs including expert witness and arbitration fees and pre- and post-judgment interest. Each party will be responsible for attorneys' fees and interest associated with the other party's efforts to collect monies owed under this Agreement. Notwithstanding anything to the contrary, the parties shall have the right to seek any interim, provisional or conservatory measures, such as preliminary injunctive relief and temporary restraining orders, in any court of competent jurisdiction.

Force Majeure: If acts of God or government authorities, natural disasters, or other emergencies beyond a party's reasonable control make it illegal or impossible for such party to perform its obligations under this Agreement, such party may terminate this Agreement upon written notice to the other party without liability.

Notice: Any notice required or permitted by the terms of this Agreement must be in writing.

Assignment: Group may not assign or delegate its rights or duties under this Agreement without Hotel's prior approval.

Severability: If any provision of this Agreement is held to be invalid or unenforceable that provision will be eliminated or limited to the minimum extent possible, and the remainder of the Agreement will have full force and effect.

Waiver: If either party agrees to waive its right to enforce any term of this Agreement, it does not waive its right to enforce any other terms of this Agreement.

Appendix: The appendix below is one inseparable part of Agreement between Group and Hotel and is valid after signing.

Booking Status: No accommodation rooms and/or function space have been reserved on your behalf. To confirm the accommodation rooms, please reply to us in writing by **Wednesday 16 May 2018**.

Agreement constitutes the entire agreement between the parties, supersedes all other written and oral agreements between the parties concerning its subject matter, and may not be amended except in writing signed by Hotel and Group.


