2. Commitment Policy

- Amend the number of allotments, number of committed room nights and contract value in clause II. COMMITMENT POLICY in Commitment Contract as below:
 - + Party A commit to reserve 09 allotments per night to confirm reservation from Party B during the validity of the contract. The un-sold allotments will be released 7 days prior to arrival date. Any booking from Party B within 7 days prior to arrival is subject to availability.
 - + Party B must guarantee to sell 400 committed room nights for the whole period of contract.
 - + If the total of room night from Party B which is confirmed under this contract is less than 400 room nights, Party B still need to pay the total price of contract value VND 700,000,000. Therefore the deposit will not be refunded in any situation.
 - + If the total of room night from Party B which is confirmed under this contract is more than 400 room nights or contract value VND 700,000,000, Party A will send the final reservation list on 20th August. After deducted for the deposit, Party B must pay for the rest within 3 days after received request from Party A.

3. PAYMENT: Amend the payment term as following

Date	Amendment Payment Term
02 July 2019	Party B must pay 100% of the contract value VND 700,000,000 right after received the contract amendment.
20 August 2019	Party A will send reservation list and ask for the final payment If necessary. After deducted for the first and second deposit, Party B must pay for the rest within 3 days after received request from Party A.

- Other terms and conditions which are not stated in this Contract Amendment will be applied as Original Commitment Contract.
