You therefore agree to abide by all terms relating to the confirmation of guestrooms, attrition rates, rooming lists and cancellation charges set out below:

- a. You have contracted a minimum guarantee of below daily number. Should this minimum materialization not be met, or in the event of a no-show or shortening of stay, the Hotel reserves the right to charge for the minimum materialization or the entire length of stay.
- b. Hotel is relying upon Convergent Travel's use of the Room Night Commitment. Convergent Travel agrees that a loss will be incurred by Hotel if Convergent Travel's actual usage is less than below daily number out of the Room Night Commitment. Rooms picked up by Convergent Travel outside the Room-block will not count toward the Room Night Commitment.
- c. If Convergent Travel's actual usage is less than below daily number out of the Room Night Commitment, Convergent Travel agrees to pay, as liquidated damages and not as a penalty, the difference between below daily number out of the Room Night Commitment and Convergent Travel's actual usage, multiplied by the average group room rate, plus applicable taxes.

d. **Final Review: 3 days prior to arrival**

Any release in guestrooms exceeding **twenty percent (20%)** of the total room block as set forth in page 2 of this agreement, be subject to **one hundred percent (100%)** charge.

Any non-materialization, as set forth in the remaining room block will also be subject to **one hundred percent (100%)** charge based on the remaining room block.

ROOMING LIST

- a. **3 days prior to each check-in date**, you shall provide a Rooming List to the Hotel. This Rooming List will enable the Hotel to allocate the guests to specific rooms and make all other necessary arrangements to ensure that your event is a success. The Rooming List serves the additional function of providing a final confirmation of the guestrooms reserved for you.

PREPAYMENT
