Reservations:

- The tour operator shall submit all pre-buy reservations to info@99theheritage.com and the reservation department are subject to confirm 3 daily allotment and can accept stop sale 7 days per month.

- the tour operator shall submit all additional allotment reservations (freesale) to info@99theheritage.com and the hotel has the approval to accept or decline all additional allotment reservations (freesale). Room and Services are not guaranteed until reservation department has confirmed the reservation.

Extra Person and Child Policy:


- One child 0 – 3 years old can share room with parents free of charge when using existing beds.
