- Agent accepts and agrees to provide floating deposit for bookings at Conrad Bangkok Residences according to table 1 and allow hotel to apply this amount of floating deposit for all bookings.
- Agent accepts and agrees that all rates must not be distributed as free individual traveler (FIT) via any channels including online travel agencies (OTA).
- Agent accepts and realizes the supplement charge accordingly.

- Agent agrees to complete the payment according to the due date in table 1. In case that floating deposit almost exceeds balance and/or over-balance, hotel will invoice to collect additional deposit and/or other surcharges to agent and the settlement of the additional deposit and/or other surcharges must completely be settled within 7 days.
- Agent accepts and realizes that groups shall arrive and use the entrance at Conrad Bangkok Residences for registration process.
- Any delay in settlement of deposit and actual production invoices will be used to re-evaluate the floating deposit amount and credit term given to your company.
- Hotel reserves the right to charge an interest of 2% per month on overdue bills. (i.e. exceeding 30 days credit) and the agent agrees to pay any such added charges.
- Agent accepts and realizes that hotel has the right to reject bookings once hotel is running high occupancy or full house.
